T-shirt and map pickup: Ride day 7:30-9 am at the Visitor Center at LBJ State Park (main entrance off US 290).

Start times & ride distances:
 9 am: 60 & 36 miles; 9:30 am: 23 & 12 miles. Riders may not start after 10 am and must be off the road by 3 pm.



Rest stops/sag support: Snacks, water, and "potties" provided every 10-15 miles. Sag available along the course.

Directions: From Austin take US 290 west to Stonewall. From San Antonio go north on US 281 to Johnson City. From Johnson City take US 290 west to Stonewall. Just east of Stonewall, take main entrance to LBJ State Park and stop at the Visitor Center to register and pick up T-shirt and map. Ride will start and finish at pavilion/dining hall.
